Positive news among a dire environment

Dear members and friends

The first 5 months of 2022 were truly terrifying. War in Europe, dramatic shortages in food, energy and commodities, massively disturbed logistic chains, resurging inflation and interest rates, chaotic financial markets. Nothing seems to be going right. In the last decades, we have rarely, if ever, seen such a large number of very difficult situations. And we should find solutions to all of them. If it did not have such tragic circumstances, we would be reminded of the plate juggler who consistently runs from one stick to the other in order to speed them up to keep the plates from crashing down.

For little Switzerland, there were some great news among the storm: In the first 5 months of 2022, Swiss exports confirmed the great development of 2021 with the USA market clearly #1 for Swiss exports of goods. And Switzerland continued to import 11 times more US goods per capita than Swiss goods imported into the USA. This is clearly a winwin situation for both our Sister Republics.

The renowned QS University Ranking has just been published with great results for Swiss universities. With ETH Zurich at #9 and EPF Lausanne at #16, there are only two universities on the European continent in the top 20. That really raises question marks on the value for the EU to exclude Switzerland from the Horizon research program! The ranking is topped by MIT (USA), Cambridge (UK) and Stanford (USA). The best French university (PSL, Université Paris Sciences et Lettres) comes in at #26, the best German one (TU Munich) at #49.

In the coming months, the world will have to rearrange many seemingly certain arrangements and Switzerland, as an international, export-oriented country will have to find pragmatic and future-oriented solutions. Switzerland starts in a great position, but even here, the rearrangement will be accompanied by blood, sweat and tears.

So let us step back a bit, enjoy the summer weeks, tank new energy and come back revived with dynamic courage to tackle the issues. Or as we titled a report three years ago: "Switzerland, Wake Up!".

Flughafen Zurich AG

Zurich Airport has announced that as of June 1, 2022, Bettina Kunz, previously Senior Media Spokesperson, will take over as Head of Corporate Communications. Jet Aviation

Jet Aviation announced on May 25, 2022 that it has signed a completion contract for a BBJ MAX 9. This follows the signing of two BBJ MAX 8 aircrafts earlier this year. The aircraft is for an undisclosed VVIP customer and is scheduled to arrive at Jet Aviation's completion facility in Basel early-2023. The design has been created by an external designer, and will be engineered, crafted, installed and certified in-house at Jet Aviation.

Mobiliar

Nestlé

Nestlé was tapped by the White House to ship 1.5 million bottles of infant formula from Switzerland to Indiana as part of what the US Defense Department has called "Operation Fly Formula". This aims to help the country cope with a major shortfall in infant formula after production and supply chain problems left empty shelves in much of the US. Talks are underway on more shipments.

Novartis International

On April 26, 2022, Novartis announced the appointment of Aharon (Ronny) Gal as Chief Strategy & Growth Officer effective no later than August 1, 2022. Dr. Gal will lead the newly created Strategy & Growth function that combines corporate strategy, R&D portfolio strategy and business development. Dr. Gal joins Novartis from Sanford Bernstein where he is the Senior Analyst covering the US Biopharmaceutical industry.

Schaffner Holding AG

On May 5, 2022, Schaffner reported that Urs Kaufmann, Chairman of the Board of Directors, has decided to step down from the Board for personal reasons at the Annual General Meeting in January 2023.
